SLED CHARGES 2 WOMEN FOLLOWING DEATH OF 2-YEAR-OLD

Agents with the South Carolina Law Enforcement Division (SLED) charged Maria Osterhout, 48, of Florence, SC, on Thursday, April 27, 2023, with Homicide by Child Abuse, and 3 counts of Unlawful Conduct Toward a Child. Angel Wallace, 31, of Florence, SC, was charged on Thursday, April 27, 2023, with Homicide by Child Abuse and 5 counts of Unlawful Conduct Toward a Child.

Details can be found in the attached warrants.

Osterhout and Wallace were booked at the Florence County Detention Center.

The case will be prosecuted by the South Carolina Attorney General's Office.
