I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

On April 16, 2023, the defendant, Cicely Anjenet Gillispie, was working as a Direct Support Professional, for Coastal Regional Center, located at 9995 Jamison Road, Summerville, SC, within Dorchester County, South Carolina. Coastal Regional Center is a part of the South Carolina Department of Disabilities and Special Needs. The defendant did punch the victim, [Redacted] in the face and head twice with a closed fist. The victim is a patient at Coastal Regional Center and is a vulnerable adult. These allegations were corroborated through interviews, surveillance videos, and information provided to the South Carolina Law Enforcement Division.
