I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

Between the dates of April 1, 2022, through September 20, 2022, the defendant, Jennifer Leigh Price, while employed with Greenville Technical College, as the Bursar, and charged with safekeeping, transfer, and disbursement of the college funds, did embezzle more than \$10,000 dollars of those funds. The defendant did admit to the embezzlement of the funds to use for the defendant's everyday living expenses. This incident occurred within Greenville County, SC. Warrant is based on investigation by SLED and case #34-23-0017.
