**DESCRIPTION OF OFFENSE**

**Burglary in the Second Degree**

**The affiant states there is probable cause to believe that the defendant named above did commit the crime(s) set forth, and that such probable cause is based upon the following facts:**

That on or about July 1, 2023, the defendant Ismael Jerrod Clark; did willingly, knowingly violate S.C. statute of *Burglary in the Second Degree 16-11-312*, while at 512 Boone Hill Road, within the County of Dorchester, SC in the following particulars:

That on or about July 1, 2023, at approximately 11:37 p.m., the defendant entered upon the building located at 512 Boone Hill Road, Summerville, SC. The defendant broke into the building using a baseball bat to gain entry through a window. Once inside, the defendant smashed windows, doors, and destroyed business property. The incident was recorded on the surveillance system located at the business. The affiant and others are witness to prove the same.
