Agents with the South Carolina Law Enforcement Division (SLED) charged Tyquaveon Isaiah Hartzog, 22, on Sunday, July 23, 2023, with 2 counts of Murder, and Possession of a weapon during a violent crime.

Hartzog was booked at the Allendale Detention Center.

The case will be prosecuted by the 14<sup>th</sup> Circuit Solicitor's Office.


