being duly sworn deposes and says that defendant Benjie Lamont Anderson
did within this county and state on or about 6/29/2022 violate the criminal laws of the
State of South Carolina (or ordinance of County/ Municipality of Darlington)
in the following particulars:

DESCRIPTION OF OFFENSE: Breach / Breach of trust with fraudulent intent, value \$2,000 or less

I further state that there is probable cause to believe that the defendant named above did commit
the crime set forth and that probable cause is based on the following facts:

On or about June 29, 2022 and July 7, 2022, Benjie Anderson did unlawfully use WEX fuel credit cards issued by his employer,
Envirovac, to purchase diesel fuel for unknown individuals in return for cash, which he kept for personal use. The value of the fuel
purchased was \$1212.63. This offense occurred at Fastrack #1, located at 1014 Lamar Highway, Darlington, SC, and Fastrack #3,
located at 1680 South Main Street, Darlington in Darlington County. The Affiant's belief is based upon witness statements,
audio/video surveillance recordings, and statements Anderson obtained during SLED's investigation. This being in violation of
Section 16-13-230 (A), South Carolina Code of Laws.
