SUBJECT IN OFFICER INVOLVED SHOOTING FACING ADDITIONAL CHARGES AS SLED INVESTIGATION CONTINUES

Agents with the South Carolina Law Enforcement Division (SLED) charged Timmothy Scott, 17, on Friday, August 25, 2023, with the following:

- Discharging a firearm into a vehicle, 2 counts
- Attempted Murder
- Disregarding a stop sign
- Failure to stop for a blue light
- Hit and run
- Leaving the scene of an accident
- Possession of a weapon during a violent crime
- Unlawful possession of a firearm
- Use of vehicle without permission with intent to deprive

Details can be found in the attached warrants.

Scott was previously charged on August 19, 2023, with 2 counts of Attempted Murder following an officer involved shooting incident in the City of Greenville. The officer involved shooting is still under investigation by SLED.

Scott will remain booked at the Greenville County Detention Center.

The case will be prosecuted by the 13th Judicial Circuit Solicitor's Office.
