Agents with the South Carolina Law Enforcement Division (SLED) charged Quentel Renee Brevard, 36, on Tuesday, September 5, 2023, with Obtaining a signature or property by false pretense – value over \$10,000.00.

The SLED investigation was requested by the S.C. Office of the Inspector General. Brevard was arrested with the assistance of the Lexington County Sheriff's Department.

Personally appeared before me the affiant Richard J Cullop who being duly sworn deposes and says that defendant Quentel Renee Brevard did within this county and state on or about 5/1/2021 violate the criminal laws of the State of South Carolina (or ordinance of County/ Municipality of Richland / Dutch Fork Magistrate) in the following particulars:

DESCRIPTION OF OFFENSE: Obtaining Signature or Property by False Pretense - value over \$10,000.00

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

On 05/01/21, Quentel Brevard, while residing at Columbia, SC 29203, located in Richland County, did fraudulently apply for a PPP loan. On 05/12/21, Brevard's PPP loan was funded for \$19,790, which was deposited into her bank account. Brevard claimed to own a hair salon & to have \$95,000 of gross income for the year of 2020 on her application. Brevard was not a licensed cosmetologist per the SCLLR. Brevard was the registered agent of only 1 business, Brevard Financial Services, LLC, per the SCSOS. Affiant obtained a lawful search warrant for Brevard's SFCU bank account which showed no transactions consistent with owning a hair business per her PPP loan application. Brevard was employed during 2020 & her gross income was \$47,592.97.
