being duly sworn deposes and says that defendant Luiz Alfredo Molina

did within this county and state on or about 6/4/2023 violate the criminal laws of the

State of South Carolina (or ordinance of [X] County/ [] Municipality of Chester)

in the following particulars:

DESCRIPTION OF OFFENSE: Sex / Criminal sexual conduct - Third degree

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

[redacted] On 6/4/23, [redacted] stated while she was sitting on the floor in [redacted] bedroom [redacted] Molina, forced himself on top of [redacted] in an attempt to have sexual intercourse. [redacted] was extremely uncomfortable and repeatedly told Molina, "No, get off of me" and "please stop." [redacted] also told Molina, "This is rape." Molina continued to force himself onto [redacted] as he forcibly kissed [redacted] on the side of [redacted] neck and attempted to pull down [redacted] shorts. Molina used his torso to force [redacted] from a sitting position to laying on [redacted] back on the floor and restrained [redacted] to the floor by pinning [redacted] hands to the floor and using his body weight to control [redacted] body. Molina used one of his hands to lower his and [redacted] pants, but he was unsuccessful in exposing any private parts and there was no penetration.
