The defendant did grab the victim [redacted] around the neck and push him into the wall. The victim is a resident at Wellpath Recovery Solutions and is a vulnerable adult. These allegations were corroborated through interviews, surveillance videos, and information provided to the South Carolina Law Enforcement Division.
