### **SLED CHARGES GREENVILLE COUNTY MAN WITH VEHICLE TITLE FRAUD**

Agents with the South Carolina Law Enforcement Division (SLED) charged Kevin Maurice Fuller, 56, on Wednesday, October 18, 2023, with Title Fraud.

Details can be found in the attached warrant.

Fuller was booked at the Greenville County Detention Center.

Kevin Fuller's arrest follows SLED's previous arrests of Keith Eric Fuller, 57, with Breach of Trust with fraudulent intent, and 2 counts of Vehicle Title Fraud, and Grayling Sligh, 64, with 3 counts of Vehicle Title Fraud on October 13, 2023.

The case will be prosecuted by the 13<sup>th</sup> Circuit Solicitor's Office.

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

The defendant, Kevin Fuller, did on February 24, 2022, at the South Carolina Department of Motor Vehicles (SCDMV) office in Greenville County apply for and receive a South Carolina duplicate title for a 2010 Ford VIN # [redacted]. The defendant used a "Third Party Title Pick Up" form and a forged duplicate title application to accomplish this act. In doing so, he did violate the South Carolina Code of Laws section 16-21-20. This warrant is based on SLED investigation 56-23-0463.
