### **SLED CHARGES FOURTH PERSON IN GREENVILLE COUNTY VEHICLE FRAUD SCHEME**

Agents with the South Carolina Law Enforcement Division (SLED) charged Kim D Fuller, 62, on Monday, October 23, 2023, with two counts of Title Fraud.

Details can be found in the attached warrants.

Fuller was booked at the Greenville County Detention Center.

Kim Fuller's arrest follows SLED's previous arrests of Keith Eric Fuller and Grayling Sligh on Friday, October 13, 2023, and Kevin Fuller on Wednesday, October 18, 2023.

The case will be prosecuted by the 13<sup>th</sup> Circuit Solicitor's Office.
