SLED CHARGES GREENVILLE COUNTY WOMAN IN VEHICLE FRAUD SCHEME

Agents with the South Carolina Law Enforcement Division (SLED) charged Teresa Acker, 51, on Monday, October 30, 2023, with 2 counts of Vehicle Title Fraud.

Details can be found in the attached warrants.

Acker was booked at the Greenville County Detention Center.

Acker is the latest of several subjects facing charges that resulted from an investigation by SLED's Vehicle Crimes Unit. SLED Agents arrested Kim Fuller with 2 counts of Vehicle Title Fraud on Monday, October 23, 2023, Kevin Maurice Fuller with Vehicle Title Fraud on Wednesday, October 18, 2023, Keith Eric Fuller with Breach of Trust with fraudulent intent, and 2 counts of Vehicle Title Fraud on Friday, October 13, 2023, and Grayling Sligh with 3 counts of Vehicle Title Fraud on Friday, October 13, 2023.

The case will be prosecuted by the 13th Circuit Solicitor's Office.
