Agents with the South Carolina Law Enforcement Division (SLED) charged Leanna Neomi McCray, on Thursday, November 2, 2023, with Attempted Murder, and Assault & Battery of a High & Aggravated Nature.

DESCRIPTION OF OFFENSE: Assault / Attempted Murder

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

On or about November 2, 2023, Leanna McCray did, within the county of Lee, commit the offense of Attempted Murder, to wit: McCray contacted 911 to report her vehicle stolen. Lee County Sheriff's Office Deputy (Dep.) [] responded to, [] Bishopville, SC, McCray's residence. Upon arrival, Dep. [] entered the residence and spoke with McCray then spoke with McCray's family outside of the residence. Dep. [] reentered the residence to continue speaking with McCray, who was in her bedroom with the door closed. Dep. [] knocked on McCray's door and advised her to open the door. McCray opened the door and pointed a silver revolver towards Dep. [] McCray fired approximately four rounds at Dep. [] Dep. [] fell to the floor and crawled out of the residence. The Affiant's belief is based upon evidence located inside the residence and Dep. []'s statement. This being in violation of Section 16-3-0029, South Carolina Code of Laws.
