Personally appeared before me, the affiant SS/A Bridgette Lott who being duly sworn deposes and says that defendant Shalay Ambrice Mack, did within this county and state on or about May 1, 2023 violated the criminal laws of the State of South Carolina in the following particulars: I further state that there is probable cause to believe the defendant named above did commit the crime set forth and that probable cause is based on the following facts: On or about May 1, 2023, while employed with the South Carolina Department of Motor Vehicles, 228 O'Neil Court, Suite B, Columbia, SC, in the county of Richland, Shalay Ambrice Mack, did accept \$500 of US currency via Cash App from a customer in return for performing an act in violation of her official responsibilities. By accepting something of value to influence the discharge of her official duties, she did violate SC Code of Laws Section 8-13-705 (B).
