SLED CHARGES ORANGEBURG COUNTY MAN WITH VEHICLE FRAUD

Agents with the South Carolina Law Enforcement Division (SLED) charged Jeremy Leviene Felder, 36, on Friday, November 17, 2023, with Possession of a Vehicle with an Altered VIN number, Possession of a Stolen Vehicle with a value of \$10,000 or more, and Obtaining Property Under False Pretenses with a value of \$10,000 or more.

Felder was booked at the Alvin S. Glenn Detention Center.

The case will be prosecuted by the 5th Circuit Solicitor's Office.
