SLED CHARGES YORK COUNTY MAN WITH MURDER AND POSSESSION OF A WEAPON DURING THE COMMISSION OF A VIOLENT CRIME, AND UNION COUNTY WOMAN FOR OBSTRUCTING JUSTICE

Agents with the South Carolina Law Enforcement Division (SLED) charged Antonio Woods Heath, 33, on Monday, December 4, 2023, with Murder and Possession of a Weapon During the Commission of a Violent Crime.

Heath is the second subject to be charged in this case. On July 28, 2023, SLED Agents charged John Antonia Frenchis Lowery, 31, with Murder and Possession of a Weapon during the Commission of a Violent Crime. SLED was requested by the Chester Police Department to investigate a shooting incident on July 23, 2023, that resulted in a fatality.

SLED Agents also charged Jessica Bonita Camps, 32, on Monday, December 4, 2023, with Obstructing Justice.

Details can be found in the attached warrants.

Heath was booked at the Chester County Detention Center.

Camps was booked at the Union County Detention Center.

The case will be prosecuted by the 6th Circuit Solicitor's Office.
