SLED CHARGES SUBJECT OF OFFICER INVOLVED SHOOTING WITH POINTING AND PRESENTING A FIREARM AND RESISTING ARREST

Agents with the South Carolina Law Enforcement Division (SLED) charged David Herbert Massie, 45, on Friday, December 8, 2023, with Pointing and Presenting a Firearm at a Person, and Resisting Arrest.

Details can be found in the attached warrants.

Massie was booked at the York County Detention Center.

Massie is the subject in an officer involved shooting that happened in Rock Hill on November 20, 2023. The Rock Hill Police Department charged Massie with armed robbery and Possession of a weapon during a violent crime. The Rock Hill Police Department requested SLED investigate the officer involved shooting. SLED's investigation is active and ongoing.

The case will be prosecuted by the 16th Circuit Solicitor's Office.

DESCRIPTION OF OFFENSE: Resisting / Resisting arrest with a deadly weapon - 1st offense

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

On or about November 20, 2023 in the area of 146 Herlong Ave, Rock Hill, SC, county of York, the defendant, David Massie, did willfully and unlawfully violate the South Carolina Code of Law by resisting the lawful efforts of Rock Hill Police Department (RHPD) Officers to arrest him with the use or threat of use of a deadly weapon. RHPD Officers attempted to make contact with Massie who matched the description of an armed robbery suspect. Massie pulled a firearm and defied officers verbal commands to drop the weapon. Massie was subsequently shot by officers. As Massie was handcuffed, he pulled an edged weapon from his waistband. Officers were able to retrieve the weapon after threatening to tase Massie. Probable cause is based on police investigation, recovery of evidence, victim statements, and witness statements.
