The contraband found was a firearm (Taurus G2C 9mm [Redacted] and tobacco products (Black & Mild). The defendant contacted a coworker who was still at the detention center, asking them to grab his belongings out of his (defendant's) locker inside the detention center and bring it to him in the parking lot. He also asked the coworker not to look into the bag nor tell anyone about his request. The contraband was found inside the defendant's locker after being searched by the detention center supervisors. This is in violation of Section 24-7-155, South Carolina Code of Laws.
