SLED CHARGES 17-YEAR-OLD FROM CHESTER COUNTY WITH ASSAULT & BATTERY OF A HIGH & AGGRAVATED NATURE

Agents with the South Carolina Law Enforcement Division (SLED) charged Zane Redman Roberts, 17, with Assault & Battery of a High & Aggravated Nature on Monday, February 26, 2024. The SLED investigation was requested by the Chester County Sheriff's Office (CCSO).

Details can be found in the attached warrant.

Roberts was already in custody at the York County Detention Center following his previous arrest by the CCSO. Roberts has since been booked into the Chester County Detention Center.

The case will be prosecuted by the South Carolina Attorney General's Office.

in the following particulars:

DESCRIPTION OF OFFENSE: Assault / Assault & Battery of a High & Aggravated Nature

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

On February 2, 2024, while at 1780 J. A. Cochran Bypass, Chester, SC, in Chester County, Zane Roberts did stab [REDACTED] twice in the arm and once in the leg causing injuries. The actions of Roberts could have produced great bodily injury or death. During the incident, Roberts stabbed another victim [REDACTED] in the neck and abdomen who had life threatening injuries and was airlifted to Atrium Main hospital in Charlotte, NC, for life saving treatment. Roberts stabbed [REDACTED] and [REDACTED] after a brief verbal argument. This is in violation of SC Code of Laws 16-03-0600(B)(1) Assault and Battery of a High and Aggravated Nature.
