SLED CHARGES AIKEN COUNTY WOMAN WITH CRIMINAL SEXUAL CONDUCT WITH A MINOR AND DISSEMINATING HARMFUL MATERIAL TO A MINOR

The South Carolina Law Enforcement Division (SLED) charged Murray Craig Frank, 34, with Criminal Sexual Conduct with a Minor - 3rd degree, and Disseminating Harmful Material to a Minor on Thursday, September 12, 2024. The SLED investigation was requested by the Aiken County Sheriff's Office.

Frank was booked into the Aiken County Detention Center.

The case will be prosecuted by the 2nd Circuit Solicitor's Office.

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

On or about May 4, 2024, Murray Craig Frank at [REDACTED] within Aiken County, did willfully and lewdly commit or attempt to commit a lewd or lascivious act upon or with the body, or its parts, a child under sixteen years of age. Frank (34 years of age) kissed the child (14 years of age) on the lips and neck before proceeding to place his hand on her breast above clothing. Frank also placed the child's hand on her breast under her clothing and placed his other hand above her pelvic area. This information was disclosed by the child to his mother and in a SLED Forensic Interview. This is in violation of 16-03-0655(C), THE CODE OF LAWS OF SOUTH CAROLINA, (1976), as amended.
