I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

On multiple dates between March 8, 2025 and March 11, 2025, the defendant, Alexianna Fields, did with the intent to defraud, pass a quantity of South Carolina education Lottery (SCEL) instant scratch off tickets at multiple SCEL retail locations within the county limits of Barnwell County and did receive payouts totaling two thousand and eighty-one dollars (\$2,081.00). The tickets were fraudulently acquired by the defendant from POPS #317, located at 1000 Jackson St. in Barnwell (Barnwell County), SC, where the defendant was employed. The defendant was identified by management and employee record. The affiant and others are witness to prove the same.
