SLED RESCUES 8 DOGS AND CHARGES FLORENCE COUNTY MAN WITH ANIMAL FIGHTING, CRIMINAL CONSPIRACY, ILL TREATMENT OF ANIMALS

The South Carolina Law Enforcement Division (SLED) charged Saquan Emanuel Brown, 27, with nine counts of Animal Fighting or Baiting, three counts of Criminal Conspiracy, and six counts of Ill Treatment of Animals on Monday, August 11, 2025. The Florence County Sheriff's Office assisted in the investigation.

During the operation, eight dogs were placed with the Humane World for Animals organization for veterinary care.

Details can be found in the attached warrants.

Brown was booked into the Florence County Detention Center.

BROWN was determined to own a black and white, female pit bull-type dog (Female 1) for the purpose of fighting or baiting. Social media records obtained pursuant to an ongoing dogfighting investigation indicated BROWN claimed ownership of Female 1, who BROWN referred to as "Cocorose." BROWN produced an audio/video recording of Female 1, stating, "that's her rn." [right now]. Female 1 had numerous visible linear scars across her chest & front legs consistent with scarring from dogfighting injuries. The location in the video was consistent with BROWN's Timmons ville. These facts are in addition to the large amount of physical & digital evidence seized by SLED in a large dogfighting conspiracy involving the Defendant & his co-conspirators. Such acts violate S.C. Code of Laws section 16-27-0030.

The video showed BROWN & his co-conspirator standing over the dogs as they fought, encouraging the fight, & repositioning the dogs to reengage as desired. Further, BROWN was developed as an identified match to the video through facial recognition and SCDMV. These facts are in addition to a large amount of physical & digital evidence seized by SLED in a large dogfighting conspiracy. Such actions violate S.C. Code of Laws section 16-17-0410.
