The South Carolina Law Enforcement Division (SLED) charged Timothy Carroll Bourgoin, Jr., 38, with Embezzlement of Public Funds - Value \$10,000 or More on Wednesday, September 10, 2025. The Town of Latta requested the SLED investigation.

Bourgoin, Jr. was booked into the Dillon County Detention Center.

The case will be prosecuted by the 4th Circuit Solicitor's Office.

Personally appeared before me the affiant, Special Agent Michael Connelly who being duly sworn deposes and says that defendant: Timothy Carroll Bourgoin, Jr. did within this county and state on or about January 1, 2024 violate the criminal laws of the State of South Carolina in the following particulars:

DESCRIPTION OF OFFENSE:

Embezzlement of public funds, value \$10,000 or more - §16-13-0210(A) - (CDR CODE 3459)

PROBABLE CAUSE:

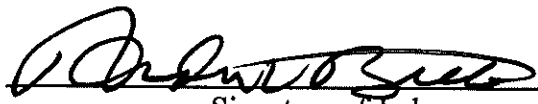
I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

Between the dates of January 1, 2024, and approximately March 19, 2025, Timothy Carroll Bourgoin Jr. in the Town of Latta, within the county of Dillon, did commit the offense of Embezzlement of public funds to wit: Timothy Carroll Bourgoin Jr., as the Town of Latta Parks and Recreation Director, managed and collected cash and electronic payments of money intended for the Town of Latta through their sports programs and did not properly account for the disposition of the money or deposit all of the money in the Town of Latta designated bank account. As Director, Bourgoin managed the collection of revenue during town-sponsored events which included applications fees; attendance gate proceeds; canteen/concessions sales; sponsorship fees; and other sources of income. Investigation indicates he also directed revenue related to town-sponsored sports events and intended for the Town Latta, directly into his personal Cash App account. Bourgoin was trusted with the collection, safekeeping, transfer, and proper disbursement of public funds on behalf of the Town of Latta; however, he failed to properly collect, account for, safekeep, deposit, and manage funds in excess of \$10,000. The affiant's belief is based upon witness statements, statements from employees of the Town of Latta, Parks and Recreation sports registration records, bank records, expense account receipts, and Cash App receipts/records. This being in violation of Section 16-13-0210 (A), South Carolina Code of Laws.
