SLED CHARGES BERKELEY COUNTY COUPLE WITH CRIMINAL SEXUAL CONDUCT WITH A MINOR AND HUMAN TRAFFICKING

The South Carolina Law Enforcement Division (SLED) charged Filipe Novais De Oliverira, 39, with four counts of Criminal Sexual Conduct with a Minor - Victim 11 to 14 Years of Age, and Trafficking in Persons - Victim Under 18 Years of Age - 1st Offence. SLED also charged Lais Olivetti Silva, 38, with Criminal Sexual Conduct with a Minor - Victim 11 to 14 Years of Age and Trafficking in Persons - Victim Under 18 Years of Age - 1st Offence. De Oliveria and Silva are married. SLED charged both subjects on Wednesday, October 8, 2025.

The Hanahan Police Department requested the SLED investigation. The Tri-County Human Trafficking Task Force and Homeland Security Investigations (HSI) assisted in the investigation.

Details can be found in the attached warrants.

Both De Oliverira and Silva were booked into the Hill-Finklea Detention Center in Berkeley County.

The case will be prosecuted by the 9th Circuit Solicitor's Office.

That between the dates of **November 9th, 2024 and June 10th, 2025**, while located at [REDACTED] in Hanahan, South Carolina, the defendant, **Filipe Novais De Oliveira**, did commit the offense of violation section 16-3-2020(C) of the South Carolina Code of Laws, 1976 as amended, **Trafficking in Persons, Victim Under 18, 1st Offense**, in that he did willfully, unlawfully, and knowingly, aid, abet, or conspire with another person to agree to give, or offer to give anything of value to a victim, who was under the age of 18, so that he could engage in commercial sexual activity with another person when he knew that the other person is a victim of trafficking in persons.

Facts to prove the above are Hanahan Police Department received a report involving minor victim 1 being sexually exploited by the defendant. During a forensic interview at the [REDACTED] Advocacy Center, minor victim 1 disclosed the defendant [REDACTED] forced [REDACTED] to have sexual intercourse with him, perform fellatio on him, digitally penetrate [REDACTED] and performed cunnilingus on [REDACTED] with the approval of the co-defendant, [REDACTED] known as **Lais Olivetti Silva**. Minor victim 1, who is [REDACTED] years old, disclosed [REDACTED] was compensated for those sex acts with perfumes, makeup, Apple AirPods and other items by the defendant, in coordination with **Lais Olivetti Silva**. Minor victim 1 disclosed **Lais Olivetti Silva** would receive money via Zelle transactions from the defendant when minor victim 1 performed sex acts with the defendant. Pursuant to a search warrant, investigators found multiple Zelle transactions from the defendant to **Lais Olivetti Silva** on the defendant's bank statement. Pursuant to a search warrant, investigators reviewed extractions of the defendant's and **Lais Olivetti Silva**'s phone that contained text conversations between the defendant and **Lais Olivetti Silva**. The phone conversations corroborate the victim's disclosure, where the defendant is found communicating with **Lais Olivetti Silva** about sexually assaulting minor victim 1. The defendant advises **Lais Olivetti Silva** to purchase material items for minor victim 1 in exchange. On the same date, the defendant's bank card was used to purchase Apple Air Pods from Apple where the buyer identified minor victim 1 as the owner of said air pods. During one conversation, the defendant tells **Lais Olivetti Silva** minor victim 1 can have [REDACTED] since [REDACTED] agreed to him performing a sexual act on minor victim 1.

The phone conversations corroborate the victim's disclosure, where the defendant is found communicating with Lais Olivetti Silva about sexually assaulting minor victim 1 and "sucking" minor victim 1's [REDACTED].

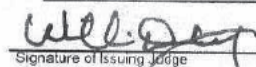

That between the dates of **November 9th, 2024 and June 10, 2025**, while located at [REDACTED] in Hanahan, South Carolina, the defendant, **Lais Olivetti Silva**, did commit the offense of violation section 16-3-2020(C) of the South Carolina Code of Laws, 1976 as amended, Trafficking in Persons, Victim Under 18, 1st Offense, in that she did willfully, unlawfully, and knowingly, aid, abet, or conspire with another person to agree to give, or offer to give anything of value to a victim, who was under the age of 18, so that any person could engage in commercial sexual activity with another person when she knew that the other person is a victim of trafficking in persons.

Facts to prove the above are Hanahan Police Department received a report involving minor victim 1 being sexually exploited by [REDACTED] the co-defendant, **Filipe Novais De Oliveira**. During a forensic interview at the [REDACTED] Advocacy Center, minor victim 1 disclosed **Filipe Novais De Oliveira** forced [REDACTED] to have sexual intercourse with him, perform fellatio on him, digitally penetrate [REDACTED] and performed cunnilingus [REDACTED] with the approval of the defendant, [REDACTED]. Minor victim 1, who is [REDACTED] years old, disclosed she was compensated for those sex acts with perfumes, makeup, Apple AirPods and other items by **Filipe Novais De Oliveira**, in coordination through the defendant. Minor victim 1 disclosed the defendant would receive money via Zelle transactions from **Filipe Novais De Oliveira** when minor victim 1 performed sex acts with **Filipe Novais De Oliveira**. Pursuant to a search warrant, investigators found multiple Zelle transactions from **Filipe Novais De Oliveira** to the defendant on **Filipe Novais De Oliveira's** bank statement. Pursuant to a search warrant, investigators reviewed extractions of the defendant's and **Filipe Novais De Oliveira's** phone that contained text conversations between the defendant and **Filipe Novais De Oliveira**. The phone conversations corroborate the victim's disclosure, where the defendant is found communicating with **Filipe Novais De Oliveira** about sexually assaulting minor victim 1. The defendant purchased items for minor victim 1 with money provided by **Filipe Novais De Oliveira** in exchange for the sex acts. Within the conversation, the defendant advises she plans to purchase the earphones in regards to a "surprise" under the approval of **Filipe Novais De Oliveira**. On the same date, the defendant's bank card was used to purchase Apple Air Pods from Apple where the buyer identified minor victim 1 as the owner of said air pods. During one conversation, **Filipe Novais De Oliveira** tells the defendant, minor victim 1 can have [REDACTED] since [REDACTED] agreed to him performing a sexual act on minor victim 1. During another text conversation, the defendant advises she will allow **Filipe Novais De Oliveira** to be with minor victim 1 alone if he agreed to having her stomach and breasts done surgically.
