SLED CHARGES RICHLAND COUNTY MAN WITH CARRYING A WEAPON ON SCHOOL PROPERTY AS INVESTIGATIONS CONTINUE INTO S.C. STATE SHOOTINGS

The South Carolina Law Enforcement Division (SLED) charged Treveion James Crawford, 18, with Carrying a Weapon on School Property on Tuesday, October 28, 2025. The South Carolina State University Department of Public Safety requested the SLED investigation.

Details can be found in the attached warrant.

Crawford was booked into the Orangeburg County Detention Center.

The case will be prosecuted by the 1st Circuit Solicitor's Office.

SLED is investigating two shootings at S.C. State. Both shootings occurred in the evening on Saturday, October 4, 2025. A woman was killed in one of the shootings. The Orangeburg County Coroner's Office identified her as Jaliyah Butler, 19. A man was injured in the second shooting. The shootings are not believed to be connected at this time, however, SLED's investigations are active and ongoing. I further state that there is probable cause to believe that the defendant named above did commit
the crime set forth and that probable cause is based on the following facts:

That on or about October 4, 2025, while in Orangeburg County SC, at South Carolina State University (SCSU), 300 College Avenue, Orangeburg, SC, defendant, TREVEION JAMES CRAWFORD, did commit the offense of violation section 16-23-0430, of the South Carolina State Code of Laws, CARRYING WEAPON ON SCHOOL PROPERTY, in that he did possess a handgun that he was carrying on his person. At approximately 8:33 p.m. a video was taken of the defendant in the courtyard area of Hugine Suites with a black in color firearm that was inside of the gray in color vest he was wearing at the time.
