The South Carolina Law Enforcement Division (SLED) charged Abdul Kabba Campbell, 33, with Abuse of a Vulnerable Adult on Monday, November 3, 2025. Wellpath Recovery Solutions requested the SLED investigation.

The case will be prosecuted by the 5th Circuit Solicitor's Office.

That on September 5, 2025, in the county of Richland, one Abdul Kabba Campbell did commit the crime of Abuse / Abuse of vulnerable adult in that the Defendant was working as Custody Officer for Wellpath Recovery Solutions, Located at 7901 Farrow Road. Wellpath Recover Solutions is a contracted provider for the Dept of Behavioral Health & Developmental Disabilities Office of Intellectual and Developmental Disabilities. The defendant did place the victim, [REDACTED] in a chokehold and slam [REDACTED] onto the ground. The victim is a patient at Wellpath Recovery Solutions and is a vulnerable adult. I further state that there is probable cause to believe the defendant did commit the crime set forth and that probable cause is based on the allegations were corroborated through interviews, surveillance videos, and information provided to SLED.
