SLED CHARGES FORMER GREENVILLE COUNTY PROBATE COURT EMPLOYEE WITH BREACH OF TRUST AND EMBEZZLEMENT OF PUBLIC FUNDS

The South Carolina Law Enforcement Division (SLED) charged Tyler J Edge Partington, 26, with Breach of Trust with Fraudulent Intent - Value \$2,000 or less, and Embezzlement of Public Funds – Value less than \$10,000 on Friday, November 7, 2025.
