### **SLED CHARGES FORMER PEE DEE REGIONAL CENTER DIRECT SUPPORT PROFESSIONAL WITH ABUSE OR NEGLECT RESULTING IN DEATH OF A VULNERABLE ADULT AND ABUSE OF A VULNERABLE ADULT**

The South Carolina Law Enforcement Division (SLED) charged Haven Alyssa Jackson, 22, with Abuse or Neglect Resulting in Death of a Vulnerable Adult, and Abuse of a Vulnerable Adult on Tuesday, April 28, 2026. The Pee Dee Regional Center requested the SLED investigation. The Pee Dee Regional Center is Operated by the Office of Intellectual and Developmental Disabilities.

Details can be found in the attached warrants.

Jackson was booked into the Florence County Detention Center.

The case will be prosecuted by the 12<sup>th</sup> Circuit Solicitor's Office.

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

On February 1, 2026, the defendant, Haven Alyssa Jackson, was working as a Direct Support Professional for the Pee Dee Regional Center, located at 714 National Cemetery Rd., Florence, SC, within Florence County, South Carolina. Jackson was the assigned staff for the victim, ██████ to ensure ██████ safety and wellbeing. While eating unapproved food during lunch, ██████ choked. Jackson had direct knowledge of the choking and was seen laughing. Jackson never provided any life-saving measures or interventions. ██████ died as a result of the choking incident. Jackson did not perform the mandated 15-minute accountability checks on ██████ and she falsified the documentation to indicate she did. Jackson neglected ██████ by failing to provide proper care. Therefore, her actions directly resulted in ██████ death. The victim is a resident of the Pee Dee Regional Center and is a vulnerable adult. These allegations were corroborated through interviews, surveillance videos.

On February 1, 2026, the defendant, Haven Alyssa Jackson, was working as a Direct Support Professional for the Pee Dee Regional Center, located at 714 National Cemetery Rd., Florence, SC, within Florence County, South Carolina. Jackson did knowingly and willfully abuse the victim, [REDACTED] multiple times throughout the day, in the following manner: Jackson forcefully pushed the victim against walls causing [REDACTED] to fall. Jackson forcefully pushed the victim backwards causing [REDACTED] to fall onto the floor. Jackson used her body to block the victim's movements and force [REDACTED] to move in specific directions. The victim is a resident of the Pee Dee Regional Center and is a vulnerable adult. These allegations were corroborated through interviews, surveillance videos.
