did within this county and state on or about 5/2/2026 violate the criminal laws of the

State of South Carolina (or ordinance of County/ Municipality of Richland Bond Court)

in the following particulars:

DESCRIPTION OF OFFENSE: Bomb / Threat, conspire to threaten, solicits another to threaten real or personal property

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

On May 2, 2026, Grant Edward Olson Jr., willfully and knowingly delivered an electronic communication, via Facebook, which contained a threat to commit an act of targeted violence. Within the contents of the post Olson threatened to commit a "small detonation" which would result in "mass casualty." The communication is in violation of Sec. 16-23-720(D), SC code of laws. The offense of Use, counseling or soliciting others to use, possessing, or threatening to use destructive device; harboring terrorist. occurred in Richland County, South Carolina; your affiant has information to prove same.
