### **SLED CHARGES TWO SUMTER COUNTY RESIDENTS WITH ALCOHOL OFFENSES**

The South Carolina Law Enforcement Division (SLED) charged both Vernice Shawann Sharper, 38, and Cedric Antonio Williams, 48, with Failure to Secure Required Beer or Wine Sale Permit, Unlawful Sale, Manufacture etc. of Alcoholic Liquors - 1<sup>st</sup> Offense, and Unlawful Storage or Possession of Alcoholic Liquors in a Place of Business - 1<sup>st</sup> Offense on Saturday, May 2, 2026.

Details can be found in the attached warrants.

Sharper and Williams were booked into the Sumter-Lee Regional Detention Center.

The case will be prosecuted by the 3<sup>rd</sup> Circuit Solicitor's Office.

The Sumter County Sheriff's Office assisted in the SLED investigation.
