SLED CHARGES SPARTANBURG COUNTY WOMAN WITH INSURANCE FRAUD AND FORGERY

The South Carolina Law Enforcement Division (SLED) charged Erin Shaquaile Robbs Kilgore, 31, with Presenting a False Claim for Insurance Payment – Value \$10,000 or More, two counts of Forgery – Value Less Than \$10,000, and Forgery – No Dollar Amount Involved on Monday, May 4, 2026. The South Carolina Department of Insurance requested the SLED investigation.

Details can be found in the attached warrants.

Kilgore was booked into the Spartanburg County Detention Center.

The case will be prosecuted by the South Carolina Department of Insurance.

I further state that there is probable cause to believe that the defendant named above did commit
the crime set forth and that probable cause is based on the following facts:

On or about April 17, 2024, in Spartanburg County, South Carolina, the defendant, Erin Shaquille Robbs Kilgore, knowingly submitted a false insurance claim to Geico Marine Insurance Company (GEICO). Robbs Kilgore uploaded two medical bills on her own behalf to the GEICO online portal. The first bill, from Atrium Health, reflected a service date of October 5, 2022, with an alleged balance of \$9,700.60. The second bill, from Spartanburg Regional, reflected an alleged balance of \$4,287.23 for services purportedly provided on October 8, 2022, and October 10, 2022. The subsequent investigation determined that Robbs Kilgore did not receive treatment from Atrium Health on October 5, 2022, nor did she receive treatment from Spartanburg Regional on October 8 or October 10, 2022, as confirmed by the medical records obtained pursuant to a search warrant. This Affiant presents these facts based on witness statements, electronic communications, and electronic records.

The document reflected two debit purchases on December 14, 2023, allegedly made to Spartanburg Regional and Atrium Health. The debit purchase for Spartanburg Regional was listed as \$4,287.23, and the debit purchase for Atrium Health was listed as \$9,700.60. The subsequent investigation into the authenticity of the financial document determined that the account number and name listed on the Citi Bank statement did not exist within the institution. This Affiant presents these facts based on witness statements, electronic communications, and electronic records.
