SLED CHARGES THREE PEOPLE IN FAIRFIELD COUNTY AFTER INVESTIGATIONS FIND ONE MINOR GIVEN A GUN, SEVERAL ALLOWED ACCESS TO ALCOHOL

The South Carolina Law Enforcement Division (SLED) charged William Wesley Jones, 38, with Delivery of a Pistol to a Minor on Tuesday, July 14, 2026. Jones was also charged with Purchase of Beer/Wine for a Person Under 21, Giving Beer/Wine to a Minor, and three counts of Contributing to the Delinquency of a Minor.

SLED also charged Brittiany A. Watts, 39, with Contributing to the Delinquency of a Minor, as well as James D. McDaniel Jr., 35, with Purchase of Beer/Wine for a Person Under 21 and Giving Beer/Wine to a Minor Tuesday, July 14, 2026.

The Fairfield County Sheriff's Office requested the SLED investigations.

Details can be found in the attached warrants.

Jones, Watts, and McDaniel Jr. were booked into the Fairfield County Detention Center.

The cases will be prosecuted by the 6th Circuit Solicitor's Office.

On March 12, 2026, during an interview with SLED Agents, a 16-year-old juvenile stated that on December 13, 2025, he/she went to a party at the defendant's residence, located at [REDACTED] in Winnsboro, SC and observed the defendant present at the residence while he/she and multiple juveniles were consuming Twisted Tea malt beverages in the kitchen of the residence. The juvenile stated that the defendant was aware that the juveniles were drinking alcohol. The 16-year-old juvenile further stated that between November 2025 and January 2026, he/she consumed alcoholic beverages at the residence on multiple occasions in the presence of the defendant and that the defendant would often drink alcohol with juveniles, take videos of the juveniles drinking alcohol, and consuming shots of liquor.

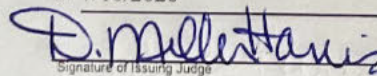
