SLED CHARGES ORANGEBURG COUNTY MAN AS INVESTIGATIONS CONTINUE INTO OCTOBER 2025 SC STATE SHOOTINGS

The South Carolina Law Enforcement Division (SLED) charged, Javarrious Jamison, 20, with Possession of a Firearm on School Property on Monday, August 17, 2026. The SC State University Department of Public Safety requested the SLED investigation.

Details can be found in the attached warrant.

Jamison was booked into the Orangeburg County Detention Center.

The case will be prosecuted by the 1st Circuit Solicitor's Office.

SLED was requested by the South Carolina State University Department of Public Safety to investigate two shootings that occurred on campus the evening of Saturday, October 4, 2025. DESCRIPTION OF OFFENSE: Weapons / Carrying or displaying firearms in public buildings or adjacent areas

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

That on or about October 4, 2025, while in Orangeburg County SC, at South Carolina State University (SCSU), in the parking lot in front of Hugine Suites, 300 College Avenue, Orangeburg, SC, defendant, JAVARRIOUS JAMISON, did commit the offense of violation section 16-23-0420, of the South Carolina State Code of Laws, POSSESSION OF FIREARM ON SCHOOL PROPERTY, in that he did possess a firearm on campus. On October 4, 2025, after a shooting occurred in the parking lot of Hugine Suites, Jamison was detained by law enforcement, in front of Hugine Suites, after he was located next to an abandoned firearm. SLED Agents interviewed Jamison and obtained a buccal swab from his person. The abandoned firearm was seized by SLED Crime Scene Agents and was sent for testing at the SLED Forensic Laboratory. It was determined that Jamison's DNA was located on the exterior of the firearm and on an unfired cartridge that was located inside the chamber of the firearm.
