The South Carolina Law Enforcement Division (SLED) charged Justice Olyvia Perrin Boyd, 31, with Attempting to Influence a Game by Coercion, Tampering, or Deception on Friday, September 11, 2026. The South Carolina Education Lottery requested the SLED investigation.

Boyd was booked into the J. Reuben Long Detention Center in Horry County.

The case will be prosecuted by the 15th Circuit Solicitor's Office.

DESCRIPTION OF OFFENSE: Lottery / Attempt to influence game by coercion, tampering, deception, etc.

I further state that there is probable cause to believe that the defendant named above did commit the crime set forth and that probable cause is based on the following facts:

That between June 3, 2026 and June 26, 2026, the defendant, Justine Olyvia Perrin Boyd, did attempt to influence the winning of cash prizes by fraudulently acquiring two thousand two hundred twenty-nine (2,229) South Carolina Education Lottery scratch-off tickets from Refuel #73, located at 6297 Hwy 90, Conway (Horry County), South Carolina. Boyd was an employee at Refuel #73 when she fraudulently acquired the tickets, which had a cash prize value of eight thousand six hundred ninety-one dollars (\$8,691.00). Boyd was captured on video surveillance taking the tickets and concealing them or giving them to multiple individuals, all without payment. The affiant and others are witness to prove the same.
